

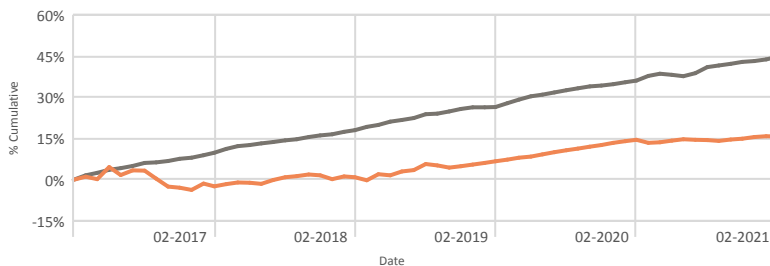
INVESTMENT OBJECTIVE

The Olympiad BCI Managed Fund of Funds is a managed prudential fund of funds portfolio seeking to deliver moderate long term capital growth with a moderate level of income.

INVESTMENT POLICY

The portfolio will comply with prudential investments guidelines. In order to benefit from positive market conditions and to provide a limited measure of capital and income protection during negative market conditions, the Manager will manage the portfolio's equity, property and fixed interest asset allocation actively to align the portfolio with the Manager's outlook of such conditions. The portfolio's equity exposure will range between 0% and 75% of the portfolio's market value.

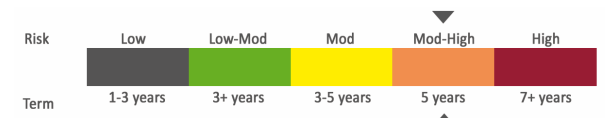

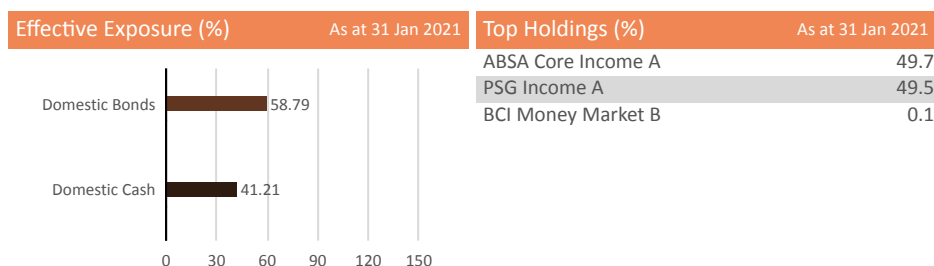
RISK PROFILE



Moderate - High Risk

- This portfolio holds more equity exposure than a medium risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a medium risk portfolio, but less than a high-risk portfolio. The probability of losses is higher than that of a medium risk portfolio, but less than a high-risk portfolio and the expected potential long term investment returns could therefore be higher than a medium risk portfolio.
